Brazilian Journalism Research - *BJR* - is a semi-annual scientific journal published by the Brazilian Association of Journalism Researchers (SBPJor). The Association is dedicated to theory and research in journalism (both theoretical and empirical work). The periodical has had a Portuguese version since the second semester of 2008. Submission of works: preference will be assigned to empirical research reports.

Articles: Should be originals in English and in Portuguese. The authors should send them by means of the journal's system to the following electronic addresses:

After submission, the Brazilian authors undertake to send the English version of the work two weeks after the notice of acceptance, if the article is approved by the advisors. The foreign authors should also send the Portuguese version of the text two weeks after the notice of acceptance, if they receive a favorable opinion for publication of the article in BJR.

It is recommended that works by doctorate, masters and graduate students be submitted in a system of co-authorship with researchers who possess a Doctors degree

Each article should contain:

- EA separate page with the article's title, the subtitle and the full name(s) of the author(s) with their current academic/professional affiliation and their current electronic mail address;
- An abstract of at least 130 and at most 150 words, and between three (3) and five (5) key words;
- A short (up to 5 lines) biographical note should also be supplied on a separate sheet;
- Each one of the two versions of the article (English and Portuguese) should be typed using the Times New Roman

font, size 12, with 1.5 cm. space between the lines, and should contain from 20 thousand to 35 thousand characters (including spaces, bibliographic references and notes), with introduction and subheadings in italics which should not be numbered, with a clear hierarchy of headings and subheadings to facilitate reading;

- Notes should be displayed at the end, before the bibliographic references;
- References and notes should be cited in the text with (AUTHOR, date, and page);
- Tables, figures, photos and illustrations should be of good quality, numbered consecutively by category and clearly identified (Examples: Figure 1, Figure 2, Table 1, Table 2, etc.);
- A reference section in alphabetical order should follow the text; use the ABNT style.

Permissions from copyright holders: authors are responsible for obtaining permissions from copyright holders for reproducing any quotation, illustration or photo previously published elsewhere.

Book reviews: the journal includes a section of reviews of books on Journalism and similar areas of up to 1,000 words. Please send comments on books to Célia Ladeira (cmmota@terra.com.br.).
